UPON THE COURT conducting a hearing on 4 August 2025 (part heard) and 8 August 2025 on the Claimant's Applications of 9 May 2025 and 6 June 2025 to set aside the Orders of 27 February 2025, 9 April 2025 and 28 April 2025

AND UPON HEARING Mr Daniel "Jim" Davies (solicitor for the Claimant) and Ms Chantelle Staynings (Counsel for the Defendant)

AND UPON the Judge determining that the Orders of 9 April 2025 were incapable of being complied with

## IT IS ORDERED THAT

1. The Claimant's Application of 9 May 2025 is granted and the Orders of 9 April 2025 and 28 April 2025 are set aside.
2. There are no orders (other than Order 11 below) in respect of the Claimant's application of 6 June 2025.
3. Each party shall file and exchange Witness Statements setting out the evidence which the party intends to rely upon by 4pm on 19 September 2025.
4. Pre-trial checklists shall be filed and exchanged by 4pm on 3 October 2025.
5. Unless the Claimant complies with Paragraphs 3 and 4 above then the Claim will automatically be struck out and judgment entered for the Defendant, with the Claimant being ordered to pay the Defendant's costs on the standard basis.
6. The Claim be listed for a 2 day trial ("Trial") in a listing window of 17 November to 22 December 2025.
7. The Trial (and any interim application in the meantime) be reserved to District Judge Bayoumi.

8. The Claimant shall lodge at Court a Trial Bundle (to be agreed if possible) no later than 5 clear days before the date of the Trial.

9. Skeleton arguments and authorities shall be served and filed no later than 3 clear days before the date of the Trial.

10. The Parties may agree to extend any time period to which these proceedings are subject for a period of up to 28 days in total without reference to the Court, provided that this does not affect the date of the Trial. Parties shall notify the Court in writing at the expiry of any such extension.

11. There is no order as to costs of the Applications of 9 May 2025 and 6 June 2025.
